



About SAADC

The Saudi Anti-Doping Committee prides on its role in protecting athletes from the dangers of doping, and in disseminating the culture of clean sport as well. SAADC is the competent authority responsible for protecting the integrity of sport from the threats of doping in Saudi Arabia.

The Saudi Arabian Anti-Doping Committee (SAADC) is a National Anti-Doping Organization in the Kingdom of Saudi Arabia. It was created in accordance with the WADA Code and the UNESCO International Convention against Doping in Sport. It was charged with implementation of a national anti-doping program and all anti-doping related matters at local, regional, continental and international levels.

SAADC has accepted and implemented the World Anti-Doping Code in conformance with its responsibilities under the Code, and in furtherance of SAADC continuing efforts to eradicate doping in the Kingdome of Saudi Arabia.

SAADC is a consultative, legislative and executive committee, linked with the Board Office of the Saudi Arabian Olympic Committee. It is an independent body with legal personality, and is a reference to all anti-doping matters nationwide in the Kingdom of Saudi Arabia. It is the sole authority to represent Saudi Arabia at the International anti-doping events. SAADC operates within the policies of Saudi Arabian Olympic Committee, and linked administratively with the General Sports Authority.



SAADC Board of Directors


- An interim Board of Directors was formed on 05/05/1425 H. (23/06/2004) to determine the work mechanism, to issue legal and organizational set of rules, and to implement a preliminary and concise national anti-doping program that would include (Awareness, Training, and Testing) for the period of 2004 -2007.
- The commencement of implementing the Doping Control Program from 2007-2009.
- After issuance of WADA Code and the "Saudi Anti-Doping Rules in Sports" in 2009, SAADC Board of Directors was re-formed by the decision No. 810 on 14/06 /1430 H. (07/06/2009).
- After the expiration of its legal term, SAADC Board of Directors was re-formed by the decision No. 6741 on 12/05/1434 H. (24/03/2013).
- The re-formation of the board took place on 01/01/2017.

Saudi Arabia & International Obligations

- Copenhagen Declaration & Issuance of the WADA Code 2003

 Both were adopted by the Saudi Arabian government by virtue of the Royal Decree No. 205 on 25/07/1424 H. (22/09/2003).
- The UNESCO International Convention Against Doping In Sport 2005, adopted by the Government of Saudi Arabia under the Royal Decree No. 350 dated 23/11/1428 H (12/03/2007).
- The WADA-accredited Saudi Anti-Doping Rules in Sport was issued On 09/02/2009
- On 01/01/2015, The updated version of the Saudi Anti-Doping Rules in Sport was published, and on 01/01/2017 the 2nd updated version of the Saudi Anti-Doping Rules in Sport was published.

The Kingdom's regional, continental, and international position

- Membership of the WADA Foundation Board for the third consecutive time (3-year term) started on 01/01/2018 up to the end of 2020. The Foundation Board is WADA supreme decision-making body.
- Membership of the WADA Experts Group (total of 8 groups).
- Saudi Arabia chairs the UNESCO Anti-Doping Conference of Parties from 2014 2019
- In addition, Saudi Arabia is a member of OCA Medical & Anti-Doping Committee and Member of the OCA West Asian Federation Medical Committee.

SAADC doping control program is based on three pillars: Education & Awareness, Training and Doping Control (Testing), each of which contributes to the effective implementation of this strategy in Saudi Arabia.

SAADC logo consists of three fronds; a frond symbolizes the Saudi environment and it represents Giving. Each frond stands for one of the Committee anti-doping program pillars: Awareness, Training, and Doping Control. These fronds enfold the initials of the Committee name in English in the shape and colors of the five Olympic Rings.



SAADC Supporting Committees

• The Saudi Arabian Anti-Doping Hearing Panel

It is an ad-hoc subcommittee which looks into cases violating the anti doping rules and regulations. It imposes sanctions and penalties against violators. It is an independent committee consisting of (9) members who do not belong to any sport federation or organizations: 1) A chair.

- 2)Two Vice-Chairs, each of whom shall be legal practitioner of not less than five years standing. 3)Three medical practitioners of not less than five years standing.
- 4) Three additional members, each of whom shall be, or has previously been, a sports administrator or an Athlete.
- 5) Each panel member shall serve a term of four years. The current term started on 01/02/2017.

During the 2017-2018 season, the Panel held 12 hearings within its investigations in the anti-doping rules violations.

Therapeutic Use Exemption Committee (TUEC):

This committee is responsible for granting or rejecting exemptions for athletes to use- for medical treatment- drugs and medicine that contain substances prohibited in sport. It is an independent body consisting of four medical consultants of different specialties. Each panel member shall serve a term of four years. The current term has started on 01 / 02/ 2017. During the 2017 -2018 season, 13 TUE applications were received; (7) granted and (6) rejected.

The Conference of Parties Bureau Meeting to the International Convention against Doping in Sport (COP6) Riyadh 3-4 March 2018.

The Kingdom of Saudi Arabia hosted over two days the first meeting of the Bureau of the sixth session of the Conference of Parties to the International Convention against Doping in Sport (COP6), knowing that the kingdom presides this conference since the year 2014.

Participating Countries

The Dominican Republic - Korea - Romania - UK- Togo, and the Kingdom of Saudi Arabia. The Russian Federation participated as representative of the APPROVAL COMMITTEE OF THE UNESCO FUND FOR THE ELIMINATION OF DOPING IN SPORT, in addition to the participation of: the Council of Europe, and WADA as observers, and Former Representative of Senegal to UNESCO, and the Secretary of the International Convention against Doping in Sport as guests.

The following issues were addressed in the meeting:

- Working methods of the COP6 Bureau COP6 Resolutions and adoption of a planning for the implementation of the Resolutions.
- Follow-up to the resolution concerning Values Education as one of the core challenges to strengthen the implementation of the Convention and consideration by Bureau members.
- Follow-up to the resolution related to the Policy Advice Project in the Russian Federation.
- Evaluation of the International Convention against Doping in Sport, and Rethinking the strategy and challenges of the International Convention against-Doping in Sport;
- Follow-up to the resolution concerning Operational Guidelines and Framework of Consequences;
- Funding and resources challenges to support the overall process of COP6 follow-up.















THERAPEUTIC USE EXEMPTIONS (TUE)

In the year 2017 - 2018, SAADC received 13 TUE applications, of which 7 were approved to be granted to athletes suffering from conditions requiring the use of drugs that may contain prohibited substances. Six (6) applications were rejected.


